8.- PARTICIPATION:

- All swimmers must be in possession of a valid CMAS licence for finswimming. The organization will control all swimmers valid licences in the reception of participants.
- Delegates and coaches must be federated.
- Each swimmer may take part in three individual events, plus the relay.
- Each team may enter a maximum of 12 swimmers.

9.- CONTROL: The development of the competition will be controlled by the Territorial Referees' Committee from EHUIF, who will designate the Competition Judges.

10.- COMPETITION EQUIPMENT: All the equipment used in the competition must comply with the CMAS Competition Regulations. The committee will check equipment in the reception of participants.

11.- PROVISION OF LOADS FOR IMMERSION TANKS: The organization will facilitate the filling of the tanks to a max. pressure of 200 Atm. Any tank out of marked control date (3 years) will not be filled. The cylinders to be used during competition must be delivered to the organization on Friday the 19 of February from 18:00 to 21:00 h.

12.- SCORING: The present CMAS table will be used as reference.

13.- CLASSIFICATIONS: The competitors will be ranked individually according to the scoring results.

14.- PRIZES: From all the races for each swimmer, the race with highest score will be considered. In this way the first three men and women will be awarded with trophy and cash prizes, as follows:

- 1st place. Trophy, Txapela and 300€
- 2nd place. Trophy and 200€
- 3rd place. Trophy and 100€

All participant teams will receive a gift.

15.- PARTICIPANT RECEPTION: The participants' reception will be hold in the Ordizia council swimming pool (Majori Sports Center) on Friday the 19 of February from 18:00 to 21:00 h. During this period of time, two lanes will be available for training.



16.- INSCRIPTION:

- The **Preliminary inscription** must be sent to the organizer before the 22 of January 2010 (annexe 1).
- The **final inscription** must be sent to the organizer before the 29 of January 2010 (annex 2).
